Donor Statement of Understanding: (required – please read and sign)

I understand that changes in the U.S. tax laws affecting vehicles donated after January 1, 2005 limit the amount that I can claim as a tax deduction. I understand that Goodwill will make the decision as to whether this vehicle is suitable and appropriate to sell themselves or if this vehicle will be sold at auction.

If Goodwill sells this vehicle, I understand that the amount that I can claim as a tax deduction will be equal to the gross proceeds from the selling of the vehicle. I understand that based on this vehicle's condition, Goodwill may sell this vehicle at auction and that the sales' proceeds may be less than fair market value of this vehicle.

I understand that Goodwill sells vehicles that are in extremely poor condition for salvage. If this vehicle is sold for salvage, I understand that the amount that I may take as a deduction will be equal to the gross proceeds of the sale, which may be as low as \$25.00.

If Goodwill matches this vehicle with a family, I understand that the amount that I can claim as a tax deduction will be based on the fair market value of this vehicle as of the date that the vehicle is donated. I understand that determining the fair market value of this vehicle is my responsibility.

If Goodwill matches this vehicle with a family, and if I believe that the vehicle I am donating has an estimated fair market value over \$5,000, I understand that a written appraisal is required before the vehicle is donated and obtaining an appraisal is my responsibility. If the vehicle appraises for more than \$5,000, I understand that I would be eligible to deduct the appraised amount if Goodwill matches the vehicle with a family. However, if Goodwill sells the vehicle, the amount of my tax deduction would be limited to the amount that Goodwill receives from the sale, regardless of the appraised value.

I understand that Goodwill will send me a statement within 30 days of the date this vehicle was sold or matched letting me know how this vehicle was used and what the amount is that I can claim as a tax deduction if the vehicle was sold.
